NOTICE OF A TAX INCREASE
AND
PUBLIC HEARING ON
PROPOSED BUDGET AND TAX LEVIES
FOR CITY OF GAUTIER, MISSISSIPPI

The City of Gautier will hold a public hearing on its proposed budget for fiscal year October 1, 2013 through September 30, 2014 on September 03, 2013 at 6:30 p.m. at the City of Gautier Council Chambers, located at 3330 Hwy 90, Gautier, Mississippi. At this meeting, a proposed ad valorem tax revenue increase in the proposed budget will be considered. This public hearing is open to the public and all citizens are encouraged to attend.

The City of Gautier is now operating with projected total general fund budget revenues of \$9,259,213. Thirty-one percent (31%) or \$2,839,286 of such revenue is obtained through ad valorem taxes. For next fiscal year, the proposed budget has total projected revenues of \$9,256,267. Of that amount, thirty-three percent (33%) or \$3,096,023 is proposed to be financed through an ad valorem tax levy.

The Library tax assessment will remain at one mill or \$116,954.

The Debt Service Fund assessment will remain at 6.75 mills of which 2.44 mills or \$285,368 is for repayment of the \$2.3 million dollar Katrina Bond and 4.31 mills or \$504,072 is for repayment of the 7 million dollar General Obligation Bond.

For next fiscal year, the City of Gautier plans to increase the General Fund Assessment millage rate by 2.44 mills from 24.35 mills to 26.79 mills. The decision to increase the ad valorem tax millage rate for fiscal year 2014 above the current fiscal year's ad valorem tax millage rate means you will pay more in ad valorem taxes on your home, automobile tag, utilities, business fixtures and equipment and rental real property.

Any citizen of the City of Gautier is invited to attend this public hearing on the proposed tax increase, budget and tax levies for fiscal year 2014 and will be allowed to speak for a reasonable amount of time and offer tangible evidence before any vote is taken.
